## ANDREW'S STORY

WVCA met Andrew and his family in 2020. During his first year, Andrew stayed home due to his health conditions, but continued to stay in touch with his teachers and therapists. Teachers wrote emails, Miss Jane shared multiple Occupational Therapy (OT) videos on YouTube, and Miss Beth held regular virtual meetings for Speech Therapy (SP) sessions as well. All of these activities helped Andrew catch up with his peers. Andrew officially started Preschool in the Spring of 2021. One of the things that Andrew's parents love most about WVCA is the communication from his teachers and therapists. As Andrew started in-person classes, his teachers and therapists made sure his parents were kept up to date with daily activity reports, therapeutic reports, and parent-teacher meetings.

Andrew's family loves that WVCA embraces every child with patience and tolerance. In the words of Andrew's father, **"All of Andrew's** teachers and therapists have given him great



patience toward his uniqueness...Each time Andrew faces challenges, his teachers are on his side, work with him, encourage him, and cheer happily as he overcomes obstacles."

In hearing directly from Andrew's therapists, they have seen great progress in his occupational, physical, and speech therapies. Miss Jane (OT) shared: "We are all so proud of Andrew's progress and have seen the impact of a team approach to providing the just right challenge and effective strategies for him. In the classroom and during therapy sessions, we have seen how the use of praise, songs, and incentives have motivated him to learn and engage. These strategies have allowed for scaffolding of his skills, so he continues to progress toward his goals." Miss Beth (SP) shared: "Andrew has been working hard towards building his expressive communication through verbal language. At the beginning of the year, Andrew was a quiet student --primarily communicating through pointing and gestures. Fast forward to today, Andrew will hum familiar songs, verbalize names of his family members (Mama, Dada, Amy), request his favorite character - 'Peppa Pig' and say 'hi' to everyone he passes in the school hallway!"

To sum it all up using Andrew's father's words: "In parents' life-long journey to make our dreams most beautiful, please take my word for it, WVCA is a trustworthy comrade. Because of love, WVCA's impact on her students could easily be felt after many years."

We are incredibly grateful to play a part in the lives of children, just like Andrew.






# OUR PROGRAMS

WVCA's largest program is our Together We Grow Preschool, licensed by the PA Department of Education State Board of Private Academic Schools and Department of Human Services in a Keystone STAR 4 Center. Additionally, our Kindergarten also serves students with developmental delays and typically developing children. Our programs are designed to give children the opportunity to grow in all areas of development. WVCA also offers physical, occupational, and speech therapies to students in need. Another one of our programs is our partnership with PA Early Intervention to offer home-based therapy and education services for children from birth through three years of age. In addition, we host the CATCH (Childhood Autism Team Check) Clinic which helps to diagnose autism and related conditions as appropriate.

# **OUR FACILITY**

#### WVCA is located at 1133 Wyoming Avenue, Forty Fort, PA 18704.

Our facility consists of our 10 classrooms, Occupational, Physical, and Speech therapy suites, handicap accessible playgrounds, and an outdoor STEAM learning classroom. We also have one of the area's few multisensory rooms. WVCA has been in this current location for over 15 years - before this facility, our agency was located at the Kirby Health Center in Wilkes-Barre for more than 80 years. While our school is in Forty Fort, we serve children from all over the Wyoming Valley, as well as surrounding areas. WVCA's school year traditionally starts the week before Labor Day and ends in early June. WVCA also run an extended school year program in the Summer and offers year-round childcare.






